The Director recommended that the Dispatchers not be required to use it. She said that they would not be disciplined for not using it. How would that work for FOIA. Save for 30 days, based on the state's retention schedule? Cherie to check. Two separate technologies audio and video. Cherie will have more answers after going to Richmond. Advantages would be for medical calls so the Dispatcher could see what was happening. Policy would have to be written about the usage for Police, etc. don't want there to be liability.

Person who sends the video would be responsible if there is a FOIA. They would get questioned if there was an investigation. Issues could be that we would question why the video was used or not used. It was suggested that the supervisor decide whether a video was used or not, not the individual dispatcher. What is beneficial to the operation? We would need more than a 30-day trial period.
